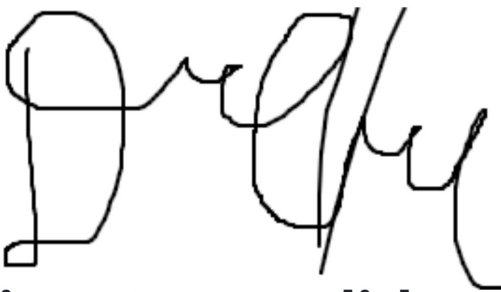
in relation to initiating and carrying out legal proceedings, as well as acting as legal representatives before the competent courts and bailiffs;

5. Re-authorize third parties with the rights listed above (items 1 to 4).

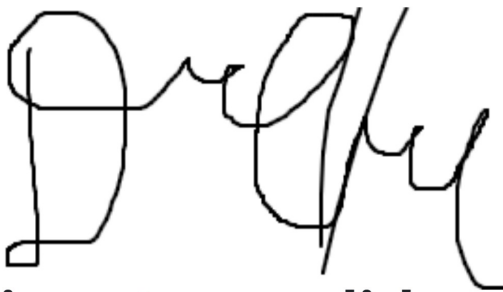

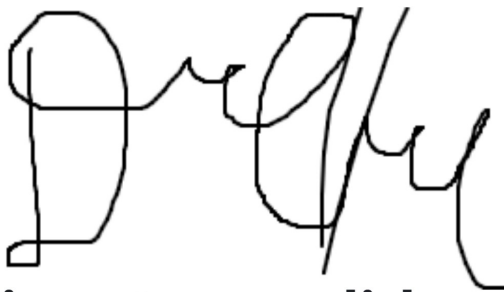
