3. Collect and receive all sorts of payments in relation to the Claim on behalf of the Client to Vidora's account in below bank details or another bank account indicated by the authorized entities;

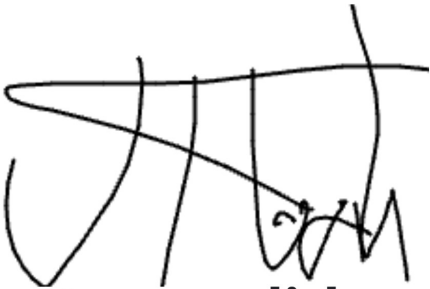

5. Re-authorize third parties with the rights listed above (items 1 to 4).

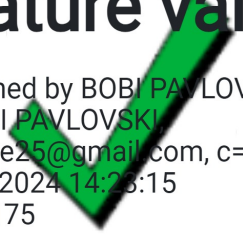
