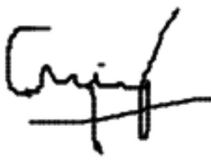

5. Re-authorize third parties with the rights listed above (items 1 to 4).

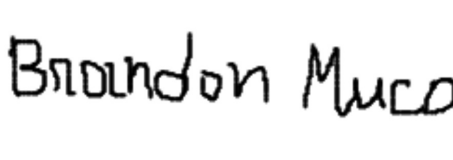

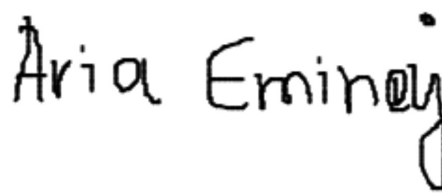
